## 9. Items for Discussion

# 9.1 <u>Annual Accounts: Certificate of Exemption</u>

Councillors acknowledged that as both the Parish Council's gross income and gross expenditure were less than £25,000 that they qualify for exemption. The Exemption Certificate was therefore signed.

9.2 <u>Annual Accounts: Accounting Statements 2022/23</u> - the figures on the statement were read out and agreed by all, then signed by the Chairman.

- 9.3 <u>Annual Accounts: Annual Governance Statement</u> the statements were read out and agreed by all, then signed by the Chairman.
- 9.4 Insurance Renewal agreed to renew Insurance policy with BHIB for £293.02.
- 9.5 <u>Village Hall Ownership</u> this was discussed in the Annual Parish Meeting which preceded this meeting, so was not discussed again here. However, for information purposes, a separate meeting will take place between the land owner (Valerie Mack) and the Village Hall Committee, as it is not a Parish Council issue.
- 9.6 <u>Postwick Park and Ride the Parish Council</u> was asked to sign a letter drawn up by Postwick Parish Council to petition for the reinstatement of the Postwick Park and Ride bus service. All Councillors agreed to add Beighton Parish Council's name to the list of signatories on the letter. Clerk to inform Cllr Eleanor Laming (BDC) who had sent out the correspondence.
- 9.7 <u>Cluster Meeting (local ParishCouncils)</u> in response to an invitation from Reedham Parish Council to be part of a cluster group of local Parish Councils and to take part in a meeting (date yet to be confirmed), all Councillors in agreement that BPC should be involved and represented. Clerk to reply to Reedham Clerk.
